Reminder: Insurance Licenses WILL NOT Expire During the COVID-19 Emergency

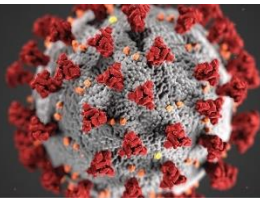
As long as your MA insurance license was in good standing as of March 10, 2020 (the day Governor Baker declared a state of emergency in MA), it is extended and will remain valid until 90 days after the state of emergency is lifted, even if it would otherwise have expired. [READ MORE](#)

RMV Update: Further Extensions for Licenses, Permits, Inspection Stickers, and Passenger Registrations

Effective immediately, further extensions will be implemented for expiring motor vehicle inspection stickers, passenger plate registrations, professional credentials, and licenses and permits, including Commercial Driver's Licenses and Permits (CDLs / CLPs). [READ MORE](#)
